HAITI'S INFLUENCE ON ATIBELLUM AMERICA | Alfred N. Hunt

The Haitian Revolution began in 1791 as a slave revolt on the French colonial island of Saint Domingue and ended thirteen years later with the founding of an independent black republic. Waves of French West Indians—slaves, white colonists, and free blacks—fled the upheaval and flooded southern U.S. ports—most notably New Orleans—bringing with them everything from French opera to voodoo. Alfred N. Hunt discusses the ways these immigrants affected southern agriculture, architecture, language, politics, medicine, religion, and the arts.

TAKING HAITI: MILITARY OCCUPATION AND THE CULTURE OF U.S. IMPERIALISM, 1915-1940 | Mary A. Renda

In July 1915, U.S. armed forces occupied Haiti, where they remained until 1934. Renda explores the intellectual underpinnings of the U.S. military and political actions and how the occupation affected American intellectuals and artists. Supporting the economic and military reasons for the occupation was a sense of paternalism and racism. Haitians were seen as a backward, inferior people needing the white man's benevolent protection. This protection turned at times to violence, as U.S. marines suppressed Haitian uprisings during the occupation.
